This two-part program addresses the resilience and longevity of swing bed programs while reinforcing the urgency to reinvent services to meet the specific needs of each rural community. Multiple issues face fledgling and established swing bed programs, such as staffing and training, significant skilled nursing changes in October 2023, and compliance audits from financial and clinical expectations. Resilience is fortified by staying current with regulations and then continual reinvention of a swing bed program to meet current needs. This discussion will center on finding each program's strength, uniquely answering their community's needs.
